# Blessing's Miracle Gift of Sight



When Blessing was just a baby in Uganda, his father died. Then Blessing began to show the first signs of being blind with cataracts. This was too much for his mother, who abandoned him and disappeared when he was just six months old.

Unable to see clearly, Blessing memorised the narrow track to school, knowing that education was his one chance to escape poverty. Yet he was stuck in the 'baby class', because he could not see anything on the board or in books.

Other children hardly ever played with him, they just excluded him, teased him and called him names because he could not see.

But thanks to generous supporters like you, he did not stay like that. Blessing was found by a **cbm**-funded partner and taken to hospital where he received life-changing cataract surgery to restore his sight. Since he was blind for so long, he also needed glasses. His grandmother could never afford any of this, but because of supporters like you, this was made possible.

Today, Blessing can see his way to school like other children. He has caught up on his classes and he has made new friends. His future is bright and free from the double disadvantage of poverty and disability. This is the difference a gift in your Will can make.

Having a Will is important because it ensures that your assets will be distributed the way you choose them to be.

# Why your Will to help is needed

In our world people with disabilities, like Kevine and Edward, are often unable to access basics like education, nutrition, sanitation and health care. They can also be excluded from jobs and community life.

Without these opportunities, people with disabilities often fall deeper into poverty – and become more vulnerable to illnesses that can lead to further disability.

The cycle of poverty and disability is hard to escape. With your gift, we'll work to break this cycle.

# How to include **cbm** in your Will

Thank you for considering leaving a gift in your Will to **cbm**.

As Wills can be complex, it's always best to have advice from a solicitor or trustee company. They can ensure the right legal processes are followed in line with your wishes, to ensure your gift goes where you intend.

If you would like to make a difference in the lives of the world's poorest people with disabilities, you can use the wording on the following page.

# Ways to leave a Gift in your Will

As a simple guide, you can take the following examples of wording to your legal advisor:

## 1 RESIDUARY

This is where you give what is left in your estate to **cbm** after all estate debts and expenses are met and your family has been looked after. It's the simplest and most effective way to support **cbm**.

"I give my residuary estate to Christian Blind Mission International (New Zealand), Charities Commission Registration Number CC26154, of Unit B, 112 Bush Road, Albany, Auckland 0632, for its general purposes.

I also declare that the receipt of the authorised officer for the

time being of the organisation shall be a full and sufficient discharge to my executors/trustees."

## 2 PERCENTAGE

You can leave a percentage of your estate to **cbm**. This gives longevity to your Will as your gift will keep pace with inflation and the overall value of your estate.

"I give (insert percentage) % of my residuary estate to Christian Blind Mission International (New Zealand), Charities Commission Registration Number CC26154, of Unit B, 112 Bush Road,

Albany, Auckland 0632, for its general purposes.

I also declare that the receipt of the authorised officer for the time being of the organisation shall be a full and sufficient discharge to my executors/trustees."

## 3 SPECIFIC GIFT

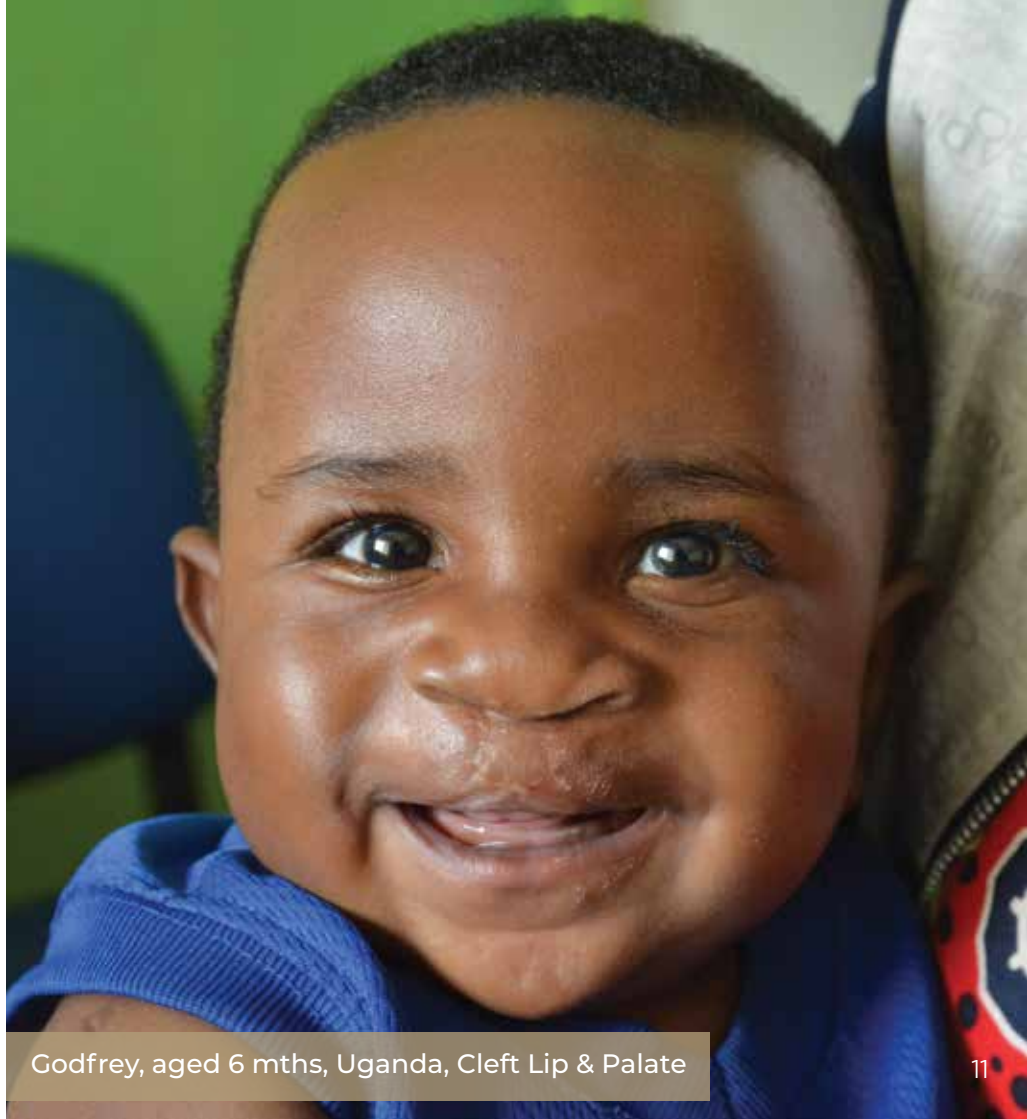
This is where you give **cbm** a specific sum of money or specific property such as real estate or an item of value (such as a painting or insurance policy). This bequest will only take place if you own the asset at the date of your death.



“I give (specific assets such as real estate, shares, etc, or specific sum of money) to Christian Blind Mission International (New Zealand), Charities Commission Registration Number CC26154 of Unit B, 112 Bush Road, Albany, free of all duties and encumbrances for its general purposes.

I also declare that the receipt of the authorised officer for the time being of the organisation shall be a full and sufficient discharge to my executors/trustees.”

Note: **cbm** New Zealand’s legal name is Christian Blind Mission International (New Zealand).

Victoria's  
Dignity has  
been Restored

## At just 22 years old, Victoria lost five babies in five years to miscarriages and stillbirths.

If that wasn't enough, after the traumatic birth of her fifth baby, she suffered from obstetric fistula, which occurs when the baby becomes stuck in the birth canal, tearing a hole and causing incontinence.

This must have been devastating. At the same time Victoria was grieving her fifth child, she had to deal with a debilitating health condition – one that could easily be resolved if she was living in the developed world.

Forced to live with this unbearable health condition, Victoria became isolated and could not leave the house because she smelt and constantly leaked urine. She suffered abuse, discrimination and self-doubt.

Yet one thing kept Victoria going – she knew there was an operation that could reverse this hugely distressing health problem.

She never lost her faith in God. She prayed alone at night for God to heal her from fistula.

By leaving a gift in your Will, many more women like Victoria will be healed and welcomed home and cherished by their husbands, family and friends.

Thanks to people like you,

## USEFUL WILL DEFINITIONS

**Will:** The document in which you specify who is to administer your estate (see Executor) and who is to receive your assets upon your death.

**Bequest:** A direction in your Will to leave a gift (money, real estate or other assets) to a specific person, organisation or charity. Also sometimes called a legacy.

**Probate:** The process whereby your executor 'proves' that your Will is your final, valid Will. It involves an application to the Supreme Court for a 'grant of probate' which, once received, formally authorises your executor to act on behalf of your estate and enables them to deal with your assets in accordance with your Will.

**Codicil:** A document that amends, rather than replaces. A codicil may add or revoke small provisions, or may completely change gifts given under your Will.

**Executor:** This is the person (or trustee company) who you appoint in your Will to act on behalf of your estate after your death to ensure that your assets are distributed in accordance with your Will.

**Beneficiary:** Any person, organisation or charity who stands to receive something from your estate.

**Residuary estate:** The remainder of your estate after your debts are paid, estate expenses are met and gifts in your Will are made.

## TYPES OF BEQUESTS:

- Percentage or fractional part: A gift expressed as a percentage or a fractional part of your residuary estate.
- Specific: Giving a specified item, such as real estate, shares or personal chattels.
- Pecuniary: A gift of a sum of money.
- Whole estate: Giving your entire estate is usually done when there are no other preferred beneficiaries, or by those wanting to achieve something very significant with their legacy.

## YOUR QUESTIONS ANSWERED

### Do I need help to write my will?

We suggest you seek the advice of a solicitor or trustee company to ensure your Will is legally sound. The wording of your Will is important, so please

refer to page 10 of this booklet when including **cbm** in your Will. We would also love to help you, and invite you to contact our friendly team personally on 0800 77 22 64.

### When should I write my Will?

If you do not have a Will, it is recommended that you write one as soon as possible. You should also update your existing Will whenever your circumstances change – such as when you retire or when a grandchild is born.

### Can I choose a specific area of **cbm's** work?

To ensure your Will is able to help those most in need, we ask that you keep your bequest quite general. We will fulfil your wishes to the best of our ability, in accordance with our mandate to improve the quality of life of people living with disability in the world's poorest countries.

### Who should my executors be?

Being an executor is an important personal responsibility that can be time consuming and require complex decisions. It is wise to consider a professional and independent executor, to minimise the burden on your family and friends at a difficult time.

#### USEFUL INFORMATION

- ① Due to ongoing changes of circumstances, it is recommended you review your Will every seven years to ensure it reflects your current wishes.
- ② It is advisable to seek legal counsel when preparing or updating a Will.
- ③ It is advisable to seek legal counsel when appointing Guardianship, Executor, Enduring Attorney and Power of Attorney.
- ④ Seeking legal advice also provides the confidence that your assets will be distributed according to your wishes.
- ⑤ When leaving a gift in your Will to **cbm** you'll need to provide the following wording to your legal advisor: Christian Blind Mission International (New Zealand), Charities Commission Registration Number CC26154, of Unit B, 112 Bush Road, Albany, Auckland 0632.
